## Our Scheduling & Cancellation Policy

With inflation on the rise these past years, we have chosen not to increase our rates for private or group sessions. However, we kindly ask for your cooperation in helping us reduce the administrative time spent on each transaction. Thank you for your understanding.

- 1) Cancellation/Rescheduling Policy** Unless there are exceptional circumstances, such as extreme weather or unforeseen emergencies, we adhere to the industry standard of requiring a 48-hour notice for cancellations or rescheduling. Tuition is non-refundable for cancellations made with less than 48-hour notice.
  - For private lessons canceled with less than 48-hour notice, rescheduling may be possible if your tutor is available and willing. However, a rescheduling fee of \$50 will apply.
  - For cancellations made with adequate notice, rescheduling or canceling private lessons is allowed. However, a \$20 rescheduling/cancellation fee may apply in cases of excessive cancellations.
- 2) Booking Policy** Since we do not require clients to purchase bulk hour packages, we encourage you to schedule as many sessions as possible in a single booking. If you book fewer than 10 sessions, a \$20 registration fee (or transaction fee) may be applied to each subsequent booking after the second one. To avoid this fee, you can prepay for 10 sessions upfront.
- 3) Payment Methods** We accept payments via checks, Zelle, Venmo, and credit cards. Please note that credit card payments will include a processing fee (4% for VISA/MC and 5% for American Express).
- 4) Group Program Policy** Group program schedules cannot be canceled or rescheduled once they are confirmed.
